

Rio Blanco County Demolition Disposal Guideline

Demolishing, Remodeling or Renovating a commercial building, home or mobile home and you want to dispose of the debris at Wray Gulch Landfill?

READ THIS FIRST!

Some buildings, homes or mobile homes may contain asbestos-containing building materials. Rio Blanco County Landfill can only accept the demolition material if the following checklist has been done:

1. Owner or Contractor must check with the appropriate county or municipality building department and follow any demolition permit requirements in that jurisdiction (i.e. Town of Meeker, Town of Rangely, Rio Blanco County).
2. Owner or Contractor has the building inspected by a Colorado-Certified Asbestos Inspector.
3. The Inspector will fill out a "Notification of Demolition Form" which is submitted to the state even if no asbestos was found. Payment of a fee and a ten working day waiting period is a part of this process.
4. If the building contains friable or potentially friable asbestos, Rio Blanco County cannot take it. The Inspector may suggest other options for disposal.
5. Non-friable asbestos is abated according to the Colorado-certified Asbestos Inspector report.
6. Rio Blanco County Landfill requires:
 - a. If no asbestos is present: To dispose, present copies of these documents to landfill personnel:
 - i. County or municipal demolition permit (if applicable)
 - ii. Inspection Report prepared by a Colorado-certified Asbestos Inspector
 - iii. The state-issued Demolition Approval Notice
 - b. If non-friable asbestos is present: Contact the Landfill Admin. Office at (970) 878-9590 and submit a copy of:
 - i. County or municipal demolition permit (if applicable)
 - ii. Inspection Report prepared by a Certified
 - iii. The state-issued Demolition Approval Notice
 - iv. Special Waste Characterization Form filled out by owner.
 - v. The Admin. Office will review the findings and determine if the ACM (asbestos-containing material) may be disposed of at the county landfill. If it is approved, owner will complete a "Regulated Asbestos Material Waste Shipment Record" for each load. All containment and disposal procedures in the "Guidelines for Receipt of Non-Friable Asbestos Waste" shall be followed, including proper packaging, marking and scheduling.

**RIO BLANCO COUNTY GUIDELINES
FOR RECEIPT OF NON-FRIABLE ASBESTOS WASTE**

1. Non-friable asbestos containing material is material which cannot be crumbled between one's fingers. Non-friable asbestos can often be made friable if subjected to moisture or mechanical pressure. Non-friable asbestos waste which has been processed, handled or used in any way that asbestos fibers may freely be released, will not be accepted.
2. Non-friable asbestos waste will be considered on a case by case basis. Non-friable asbestos will be considered for acceptance upon review of the Inspection Report prepared by a Colorado-Certified Asbestos Inspector by the County.
3. A Regulated Asbestos Material Waste Shipment Record shall be filled out by the generator for every load of non-friable asbestos waste that is shipped to the site. The original copy of the manifest shall accompany the waste at all times until unloaded at the site. The original shall be retained by the County.
4. All non-friable asbestos wastes shall be double wrapped and sealed in minimum 6-mil plastic. The plastic shall be clearly marked "Contains Non-Friable Asbestos Materials".
5. The non-friable asbestos wastes shall be delivered to the site and unloaded by the generator or hauler in a manner which prevents the release of asbestos fibers during such operations. Secondary containment in heavy duty cardboard boxes -may be required. The secondary containment materials shall also be clearly marked "Contains Non-Friable Asbestos Wastes".
6. Incoming waste loads will be inspected by the County to verify that the asbestos waste is packaged as recommended.
7. The waste shall be scheduled for receipt a minimum of 24 hours prior to disposal. Waste disposal shall be conducted during low traffic times at the landfill. The disposal shall occur downwind and at least 100 feet from other landfill users which may be present at the site. All Landfill employees shall also be upwind during unloading operations.
8. Immediately following receipt of non-friable asbestos waste, and prior to compaction, the waste shall be covered with a minimum of NINE inches of soil. The soil cover shall be spread from upwind of the disposal area.

Additionally the waste shall be treated in a manner which minimizes the potential for increase in waste friability.

10. A pre-mobilization meeting may be required by the landfill to review addition handling procedures.
