<b>Maximum Limits for Annual Permits:</b> <ol style="list-style-type: none"> <li>1. Fifteen feet in height.</li> <li>2. Two hundred thousand pounds gross vehicle weight, subject to the maximum limits for axle weight designated on the Transport Restriction Map.</li> <li>3. Fifteen feet in width, subject to the maximum limit for width designated on the Transport Restriction Map.</li> <li>4. One hundred ten feet in length for all Rio Blanco County roads, subject to the maximum limit for length designated on the Transport Restriction Map.</li> <li>5. Thirty-five feet rear overhang Twenty-five feet front overhang.</li> </ol> <p>If an extra-legal vehicle or load operating under an annual permit exceeds any one of these maximum limits, the permit automatically becomes void. If an extra-legal vehicle or load exceeds the maximum limits for height the applicant must obtain a Single-trip Transport Permit. If an extra-legal vehicle or load exceeds the maximum limits for length, width or weight the applicant must obtain a Chapter 6 Special Permit.</p>
